II. CURRENT BUSINESS MATTERS

A. Public meeting to discuss Groundwater Sustainability Plan Policy

<u>Recommendations</u>: President Hart explained the new State Sustainable Groundwater Management Act, requiring sustainable and balanced groundwater and a local Groundwater Sustainability Plan. The Plan will likely be administered by BWD and the County. President Hart invited the group's attention to the Borrego Water Coalition Policy Recommendations in the Board package.

Jerry Rolwing pointed out the issue of how our General Plan will fit in with our water conservation program. A 70 percent reduction in water use is required over the next 20 years. Discussion followed regarding issues associated with the GSP, included politics, financing and enforcement. Trey Driscoll of Dudek explained that local agencies have primary responsibility, counties secondary. Proposition 1 money is available, but applications cannot be filed until the funding requirements are finalized.

Director Tatusko suggested retaining a lobbyist and agreed to investigate. Issues include Borrego Valley's "medium" priority due to its small population and whether this priority could be appealed, possible reduction of the Valley's defined area and analysis of impact of water use reduction on residential development.

B. <u>Discussion of potential agenda items for January 28th board meeting</u>: Agenda items for the next meeting will include the solar RFP, Club Circle Golf Course lease, Town Hall Meeting Agenda, bond counsel and designation of Board officers. A CSD Committee meeting will be scheduled prior to the Board meeting to discuss the Golf Course lease, with a Cameron Brothers representative included.

III. CLOSING PROCEDURE

There being no further business, the Board adjourned at 10:30 a.m. The next Regular Meeting of the Board of Directors is scheduled for January 28, 2015 at the Borrego Water District.

Regular meeting of December 17, 2014

MSC: Brecht/Tatusko approving the Minutes of the Regular Meeting of December 17, 2014 as corrected (Item I.G, first sentence, change "Borrego Water Coalition proposal" to "Borrego Water Coalition policy recommendations"; and in the next-to-the-last sentence, revise in part to read, "... so it can be included in the District's <u>Board package</u>, which is published on the website"; Item V.2, fourth line, revise in part to read, "... <u>past</u> years' deferred maintenance..."; and in the last line, revise in part to read, "which deals with makes land use <u>recommendations for the Borrego Valley to the County</u>,....")

F. <u>Comments from Directors and Requests for Future Agenda Items</u>: Director Brecht requested inclusion of a discussion of the UCI Burnand Research Center aquifer monitoring issues in a future Agenda. He further noted that a special meeting may be required to approve the Viking Ranch refinancing.

G. <u>Comments from the Public and Requests for Future Agenda Items:</u> Dennis Daoust spoke in favor of maintaining current water rates without a mandated reduction in usage. He noted his landscaping plan had been approved by the Board in 1999, and he has two meters, one for household use and one for irrigation. Mr. Daoust opined that a change in the plantings would reduce his property value. His primary concern was the tiered rate system. President Hart explained that the Board had postponed its review of tiered rates until next year, pending release of requirements arising from the new Sustainable Groundwater Management Act.</u>

Jim Wilson addressed the Board regarding plans for a new community park and the need for a management plan. Land has been set aside by the County and funds have been designated. He urged the Board to consider becoming involved under its park powers.

H. Correspondence: None

II. CURRENT BUSINESS MATTERS

A. <u>Selection of board officers:</u> MSC: Estep/Delahay electing Beth Hart as President, Lyle Brecht as Vice-President and Joe Tatusko as Secretary/Treasurer.

B. <u>Solar Request for Proposal Presentation, discussion and possible approval:</u> Jerry Rolwing explained that a proposal had been submitted by Tandem Solar in response to the District's RFP. The Operations & Management Committee felt the price was too high, and preferred an outright purchase of the system to a Power Purchase Agreement, so the RFP was revised to provide for a phased project. Director Tatusko pointed out that with a purchase, rebates would be available. Mr. Rolwing suggested that David Dale distribute the RFP to solar providers.

Jim Engelke pointed out a discrepancy in paragraph 2 of the RFP: The first sentence provides in part, ". . . Contractor/Vendor to . . . own a PV solar system" The next-to-the-last sentence states, "The District intends to purchase the entire system outright." Mr. Engelke further suggested including a workmanship warranty, and Mr. Rolwing agreed to discuss it with Mr. Dale.

Peter Vogel of Tandem Solar objected to the Committee's characterization of Tandem's proposal as too expensive. He felt the price was competitive and noted the estimated 20 percent savings to the District on its electric bill. Further, Mr. Vogel understood that the California solar rebate funds were exhausted and as a public agency, the District would not be eligible for a federal rebate. Mr. Rolwing agreed to check into this with Mr. Dale.

The matter was tabled until the next meeting. Mr. Dale will be asked to provide financial calculations.

C. <u>Discussion of Club Circle Lease agreement which expires June 30, 2015</u>: President Hart reported on the Executive Committee's discussions relative to the District's lease to manage Club Circle Golf Course. Bob Moore, the course manager, is willing to continue. The Homeowners' Association is not yet in a position to take over the operation. The Cameron Brothers are amenable to the District's continued management</u>. The Committee recommends continuing the lease for two more years, and the Cameron Brothers' Board is meeting today to consider the proposal. If approved, it would come back to the BWD Board for final approval.</u>

The Committee further suggested cutting the CSD fee for Santiago Estates in half, pursuant to their repeated requests. Mr. Moore's salary would have to be reduced accordingly, and he has agreed to that.

Director Estep asked how the golf course benefits Borrego Springs, and questioned if the issue should be put to a vote of the public. The extra two years would provide an opportunity to explore these questions. Mr. Wilson reiterated his idea of BWD exercising its park powers, not only at Club Circle but also for the proposed new park and Christmas Circle. Other options include an endowment and establishment of a park district, which could be a 501c3 corporation if approved by the voters. President Hart suggest reestablishing the District ad hoc Parks Committee. **E.** <u>Discussion of draft Town Hall meeting agenda:</u> Mr. Rolwing announced that the Town Hall Meeting had been scheduled for March 25 from 4:00 to 6:00 p.m. Suggested items included a summary of the Sustainable Groundwater Management Act by Trey Driscoll and David Aladjem and a report on improvements to the treatment plant and future needs. Mr. Rolwing will prepare a draft Agenda for the Board's consideration at its February workshop.

F. <u>Review of planning calendar</u>: Mr. Rolwing responded to questions from the Board regarding the planning calendar. Director Brecht requested that line 29 be changed to "Water Credit Policy."

D. <u>Approval of agreement with Best Best & Krieger LLP for bond counsel services</u> for restructuring of debt for CFD 2007-1; authorization for President to execute the Agreement in <u>such form as approved by the President and General Counsel</u>: Morgan Foley joined the meeting by teleconference. He confirmed that this would be an appropriate time to discontinue the services of Stradling Yocca Carlson & Rauth as bond counsel</u>. He agreed to draft a letter for President Hart's signature informing them of the action and asking that they forward their files to him. Mr. Foley will also notify T2 Borrego.

President Hart suggested that to take action regarding CFD matters, the BWD Board typically adjourns and reconvenes as the CFD Board. Mr. Foley concurred. She suggested that the CFD Committee work out the details of the arrangement among the District, T2 and Best Best & Krieger. The matter will tentatively be back before the Board at its February 17 meeting, with Mr. Foley participating and T2 contacted in the meantime.

RE: Involvement with the Development and Implementation of the Borrego Valley Groundwater Basin Groundwater Sustainability Plan Required Under the State's Groundwater Sustainability Act

Dear Board of Directors:

The Borrego Water Coalition (BWC) is a coalition of Borrego Valley stakeholders formed at the request of the California Department of Water Resources to address the overdraft of the Borrego Valley Groundwater Basin ("the Basin"). The BWC met for nearly two years before issuing to both the Borrego Water District and the County of San Diego ("the County") our recommendations on restoring the Basin to sustainable use (see attached).

BWC's efforts to date have been significant; the BWC's diverse membership also represents approximately 85% of all the well pumpers in the Basin. The BWC desires to remain directly involved in the development of the Ground Water Sustainability Plan (GSP), as well as its implementation to insure its compatibility with our recommendations and member needs. Stakeholder support is a critical requirement of the GSP and we would like to provide that support to both the Borrego Water District and the County as Groundwater Sustainability Agencies for the Basin during the development and implementation of the GSP for the Basin.

We request that the Borrego Water District confer with its legal counsel and advise us on the structure that the Borrego Water District recommends to insure that the BWC has a seat at the table for the purpose of development, implementation, and governance of the GSP. We believe our representative membership of stakeholders will be critical to achieving the win-win outcome that we all seek.

BWC's next scheduled meeting is March 5th. We would appreciate the Borrego Water District's input prior to that meeting. We are requesting similar guidance from the County of San Diego.


Dear Jerry,

To the Borrego Springs Water Board:

In 1998 our family purchased two lots totaling some 5 acres in the Rams Hill complex known as the Estates. Each lot had its own designated water meter. After much consultation with the general manager and various other employees of the water district about the availability of water in the future we decided to plant numerous desert plants and trees on our property. My wife who is a graphic artist laid out our intentions on a 2'x4' plan showing where every plant and or tree would be placed on the property; Jerry Rowling was present and remembers the presentation in 1999. Since this was going to be a water meter for irrigation only; our house has it's own meter, we were issued a 2" water meter to handle our water system. It should be noted that we hired an architect who specialized in citrus water systems and at great expense installed a professionally built water system to insure that our water usage was minimal.

At this point I would like to state that the BWD in 1999 gave us a mandate to irrigate our property through a designated two inch irrigation meter and as it turns out we were the only residential lot to ever obtain a two inch meter for that very purpose.

As time wore on it was determined that over a period of years that our water usage amounted to approximately 5.5 acre feet of water per year. This amount of water has never varied and it shows that we have been good custodians of our water usage.

Then, a new manager Richard Williamson was recruited from Tucson, Arizona in 2008. For numerous controversial reasons this manager decides to instigate a new system of mitigating water usage by starting his 10% solution plan, where if you used 10% less water per month based on a four year average there would be no tier in your water bill. I have never seen such an arbitrary action by a publicly run entity, ever. Just because this manager decided to pull this system out of his hat doesn't mean that this action was legal by any means. I would like to know what went on behind closed doors and I question the veracity of manager Williamson's decisions.

Also, we know now what devastation took place while this manager was here in the Borrego Valley, not only to our treasury, but other useless moves by him.

The 10% solution makes absolutely no sense at all. If you look at the pieces of it there is no logic to any of it. If we can't meet our tier quota year after year then we are not allowed to have water; after ten years or 100% of this misguided solution, the water is turned off, I say no. We have made every attempt to conserve water on our property during the past 15 years at great expense and hard work. And, although you have raised the water rates 100%, when your water bill is over \$1000.00 a month and \$300.00 of it is administrative fees, that is outrageous. It shouldn't cost that much to read our meter; that is extortion at its best.

What I would ask of the water board is this: since we are the only residence that has been issued a 2" meter, that we be allowed to purchase 5.5 acre ft of water from the district during a years period without being tiered. We will monitor with the district the amount of water used each month and we will not exceed our limit. It will allow us to turn the water off when it rains, which penalizes us now because of the four year average. We have been mandated by the BWD to utilize a 2" irrigation meter for 15 years; it is our right to have decent water rates without changing what we set out to do. We are not for profit-like the citrus and golf course owners; we are citizens trying our best to conserve water.

You members of the BWD are between a rock and a hard place and there is reason for that. The district was mismanaged for years and because of that now you are trying to inflate the treasury on the backs of the people that have saved you from bankruptcy. I implore you to do the right thing. You have been charged by the voters of this small community to represent us in a fair and responsible manner. If all of our rights as rate payers have vanished then all it does is create anarchy among the populous of this valley.

You are elected officials and often your tenure is short and during this tenure I ask you to rethink this 10% solution program that should not have ever been implemented in the first place.

U.S. Geological Survey: The USGS final report entitled "Hydrogeology, Hydrologic Effects of Development, and Simulation of Groundwater Flow in the Borrego Valley, San Diego County, California is still delayed. On my last check with Claudia Faunt on Feb. 17th, she said they were going back and forth with the illustrators on the report graphics.

STATE LEVEL

The draft program development schedule for Proposition 1 funding (water bond approved last election) has been released. For the District items of concern, the State Water Resources Control Board (SWRCB) will release guidelines in February for "Small Community Wastewater Grants", followed by workshops in March, final guidelines expected to be released in June. Also, the SWRCB will release guidelines for "Clean, Safe and Reliable Drinking Water" in April, with workshops following in May, final guidelines expected to be released in August. This grant appears to be on-going and should not have a short-term deadline. The SWRCB will have "Water Recycling" draft guidelines in February with workshops in April and final, on-going solicitations beginning in June. "Groundwater Sustainability" is being developed and not anticipated in 2015. Integrated Regional Water Management (IRWM) is "likely" (their word) to be released for the final round of Proposition 84 funding in August through the Department of Water Resources (DWR). Also, the DWR will issue guidelines for "Water Use and Efficiency Grants Round 1 - Urban and Ag" in July with public meetings in August. The final guidelines are expected in December. The DWR's "Groundwater Plans and Project Grant Program - Phase 1" is designed to address "tribal consultation, develop economically distressed area definition/tool, develop program success measures". This program is expected to have draft guidelines in December.

In addition, the Legislative Analyst's Office (LAO) has prepared a report "Implementing the 2014 Water Bond" (Attachment A).

The SRWCB is accepting comments and will be holding a Public Workshop in Sacramento on March 18th regarding the Salton Sea and revised Order WRO 2002-0013 (attachment B). Written comments are due by March 11th.

COUNTY LEVEL

The District and the County Department of Planning and Development Services continue to discuss the structure of the Groundwater Sustainability Plan. We have had some welcomed assistance from 5th District Supervisor Bill Horn's office as we move forward working with the County in preparation of the Plan. County Hydrogeologist Jim Bennett has been invited to speak at the 14th Annual Town Hall meeting on March 25, 2015 at 4:00pm in the Performing Arts Center on the new groundwater legislation.

DISTRICT LEVEL

Work continues with the Borrego Water Coalition as we begin the Groundwater Sustainability Plan process. Although the DWR guidelines are not expected until 2016, we plan to be ahead of the curve and hopefully begin the program prior to the 2022 deadline.

Infrastructure repairs, fire hydrant upgrades and cross connection control installations have kept the maintenance crew very busy this year. We anticipate more fire hydrant replacement and water main replacement, as per the Capital Improvements Program, to continue through the summer. Due to extreme working conditions, pipeline replacement projects will be completed before August, or delayed until the weather becomes more tolerable. The larger pipeline projects are very difficult with our small crew and outdated equipment. These issues will need to be addressed in the upcoming budget process.

The District has been contacted by the Borrego Springs Dark Sky Coalition in regards to their "Night Sky Friendly Business Program". I met with Dr. Jim Rickard and will be working on resolving the issues they have brought to our attention. The letter is featured in the correspondence section of the February Board Agenda Packet.

At the February 17th Board Workshop, two Requests for Proposals (RFP's) were approved. The RFP's were sent out and posting on the District website for a 1) 50 kw and 2) 100kw solar array to be constructed at the Wastewater Treatment Plant. Proposals are due March 16th at 5:00pm.

Voters approved Proposition 1 in November 2014. The bond provides \$7.5 billion to fund various water-related projects. Of this total, \$425 million was redirected from unsold bonds previously authorized by voters for resources-related purposes.



As shown in the figure, the two largest categories of funding included in Proposition 1 are water storage (\$2.7 billion) and watershed protection and restoration (\$1.5 billion).

Proposition 1 Implementation

Water Storage Funds Are Continuously Appropriated. Proposition 1 provides a continuous appropriation to the California Water Commission for the \$2.7 billion for water storage. The commission would not have to go through the state budget process to spend these funds.

Legislature Appropriates Other Bond Funds. For other bond allocations, the Legislature will appropriate bond funds to state departments. After receiving appropriations for capital projects, departments have three years to commit funds and two additional years to spend them.

Departments Select Projects. Departments will typically select projects on a competitive basis. The measure prohibits the Legislature from allocating bond funds to specific projects. However, the Legislature can provide some direction on what types of projects or programs departments select. Most funding under the bond (\$5.7 billion) is available only if recipients provide matching funding to support the projects.

State Sells Bonds. The Department of Finance works with departments and the State Treasurer's Office to determine the timing of bond sales. Generally, the state attempts to coordinate timing of bond sales to project needs in order to reduce interest costs.



State Repays Bonds With Interest. The state repays bonds over time with interest. We anticipate that it will cost an average of about \$360 million annually over the next 40 years to repay the new bond authority provided in Proposition 1.




LAO Principles: Funding Cost-Effective Projects for the State

Funding State-Level Public Benefits. Since these bonds will be repaid with state tax revenues, funds should be directed to projects that provide benefits to the state as a whole. Also, projects that have clear private beneficiaries who can pay for the projects should not be prioritized for bond funds.

Generating More Benefits Than Would Otherwise Occur. Bond funds should be targeted to projects that create benefits above and beyond those that would have happened anyway to ensure that bond funds generate *additional* benefits for the state. For example, funding projects designed to allow local agencies to meet existing state or federal regulations should be avoided.

Funding Long-Term Projects. Projects that generate long-term benefits should generally be prioritized over short-term projects or operational costs so that future taxpayers do not bear the cost of projects that do not benefit them.

Considering Trade-offs. There are often trade-offs associated with competing goals that should be considered. For example, sometimes funding the most cost-effective projects can conflict with a desire to spend bond funds quickly or assist disadvantaged communities.

SOLICITATION OF COMMENTS REGARDING THE STATUS OF THE SALTON SEA AND REVISED ORDER WRO 2002-0013

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public workshop to receive information and solicit public input regarding the provisions of the State Water Resources Control Board's (State Water Board or Board) decision relating to the Salton Sea and whether the State Water Board should take further actions to address the Salton Sea's future.

On November 18, 2014, the Imperial Irrigation District (IID) filed a Petition for Change seeking modification of <u>Revised Order WRO 2002-0013</u>, which approved a long-term transfer from Imperial Irrigation District to San Diego County Water Authority (SDCWA), Coachella Valley Water District (CVWD) and Metropolitan Water District of Southern California (MWD), to the State Water Board. As discussed below under "Issues for Discussion at Workshop," the scheduling of this workshop does not reflect a conclusion that changes to Revised Order WRO 2002-0013 would be an appropriate way to address issues concerning restoration of the Salton Sea. However, the receipt of the petition reignited discussions regarding the impending December 31, 2017 date at which time the requirement established by Order WRO 2002-0013 for IID to deliver a specific quantity of water to mitigate the effects of the transfer on the Salton Sea, resulting in the exposure of an extensive playa with fine particles that may cause significant public health impacts to surrounding communities, and accelerating the rate at which the Salton Sea becomes a highly saline environment, unable to support a viable fishery and fish-eating birds.

BACKGROUND

The Salton Sea is California's largest lake and was once famous for its sport fishery and recreational uses. It is approximately 35 miles long and up to 15 miles wide with approximately 360 square miles of water surface and 105 miles of shoreline. The surface of the Salton Sea lies approximately 232 feet below sea level. Approximately 90 percent of the freshwater inflow to the Salton Sea is agricultural drain water from the Imperial Valley. As the Salton Sea has no outlets, salts concentrate in it and nutrients enhance the formation of eutrophic conditions. Currently, the Salton Sea has a salinity level that is approximately 50 percent higher than the ocean. The Salton Sea is a critical stop on the Pacific Flyway for migrating birds, including several threatened and endangered species. The Salton Sea National Wildlife Refuge was

established in 1930 to preserve wintering habitat for waterfowl and other migratory birds. However, catastrophic die-offs of birds and fish between 1992 and 1997 indicate the Salton Sea is in serious trouble. Without a salinity control project, salinity at the Salton Sea will continue to increase until the Salton Sea can no longer support a productive fishery or fish-eating birds.

Among other things, the California Water Action Plan (January 2014) calls for protection and restoration of key ecosystems, including the Salton Sea. The California Water Action Plan provides that the Natural Resources Agency, in partnership with the Salton Sea Authority, will coordinate state, local and federal restoration efforts and work with local stakeholders to develop a shared vision for the future of the Salton Sea. The Department of Fish and Wildlife and the Department of Water Resources are immediately to begin implementing the first phase of this effort with the construction of 600 acres of near shore aquatic habitat to provide feeding, nesting and breeding habitat for birds. This project could increase to 3,600 acres or more with additional resources. Concurrently, the Natural Resources Agency and the Salton Sea Authority are developing plans for the Salton Sea that will evaluate additional restoration projects and identify economic development opportunities through renewable energy development.

On October 28, 2002, the State Water Board issued Order WRO 2002-0013. On December 20, 2002, the State Water Board revised Order WRO 2002-0013 with the issuance of <u>Order WRO 2002-0016</u>. Revised Order WRO 2002-0013 approved the long-term transfer of up to 300,000 acre-feet of water per year authorized for diversion and use from the Colorado River under IID's water right permit 7643 as follows: (1) 200,000 acre-feet of water per year from IID to SDCWA; and (2) 100,000 acre-feet of water per year swith an optional 30-year renewal period, for a total of 75 years.

The conservation and transfer of water from agricultural to urban uses is a critical part of California's Colorado River Water Use Plan, which provides a framework to reduce California's use of Colorado River water to its 4,400,000 acre-foot apportionment in normal years. To facilitate implementation of the Plan, in 2003, IID, the State of California, other California water agencies, the federal government and Indian tribes entered into a collection of agreements commonly referred to as the Quantification Settlement Agreement (QSA). The QSA was intended to settle longstanding disputes regarding the priority, use and transfer of Colorado River water. The QSA established water budgets for the parties and authorized the contracting parties to pursue the long-term transfer of conserved water from IID to SDCWA, CVWD, and MWD.

Approval of the transfer had the potential to further reduce the amount of inflow to the Salton Sea from IID, thereby exposing shoreline, which could cause air quality impacts, and increasing the rate at which the Salton Sea becomes too salty to support a viable fishery. At the time when the State Water Board approved the transfer, however, it was uncertain whether restoration of the Salton Sea would be feasible, or whether it would continue to decline with or without the transfer. In addition, providing replacement water to the Salton Sea to compensate for reduced inflows likely would entail fallowing land, which had the potential to cause socio-economic impacts within Imperial County. In Revised Order WRO 2002-0013, the State Water Board balanced the important water supply benefits of the transfer against these competing interests, and concluded that approval of the transfer should be conditioned on maintaining the salinity levels at the Salton Sea that would have existed in the absence of the transfer for a period of 15 years. The purpose of this condition was to mitigate the impacts of the transfer to the Salton Sea for a long enough period to study the feasibility of long-term restoration actions and develop a restoration plan. The Board reserved authority to add, delete, or modify the salinity mitigation

requirement in light of the results of a study on the feasibility of Salton Sea restoration. The Board also required any air quality impacts of the transfer to be mitigated.

State legislation enacted in 2003 established the Legislature's intent that the State of California undertake restoration of the Salton Sea, and required the Resources Agency to conduct a study to determine a preferred restoration alternative. In May 2007, the Resources Agency published its Salton Sea Ecosystem Restoration Program Preferred Alternative Report and Funding plan. The report considered nine separate alternatives for Salton Sea restoration and identified a preferred alternative. The preferred alternative was projected to cost \$8.9 billion and has yet to be funded. In August 2013, the Department of Water Resources, Department of Fish and Wildlife, the United States Geological Survey and the United States Bureau of Reclamation issued an interagency Monitoring and Assessment Plan in support of ecological restoration at the Salton Sea. The Monitoring and Assessment Plan will allow assessment of existing ecosystem projects as well as establish a baseline against which to measure the success of future activities, thereby contributing to more effective and targeted environmental mitigation efforts at the Salton Sea.

On November 18, 2014, IID filed a Petition for Change seeking modification of Revised Order WRO 2002-0013. The petition notes that the requirement to mitigate for the salinity impacts of the transfer to SDCWA, CVWD, and MWD will end in 2017, at which point the ongoing decline of the Salton Sea's water surface elevation and the ongoing increase in salinity levels at the Salton Sea is expected to accelerate if no program to restore the Salton Sea is in effect. Accordingly, IID requests the Board to order the parties to the QSA and the Salton Sea Authority to meet and confer in an effort to achieve consensus around a realistic, feasible restoration plan for the Salton Sea and a mechanism for funding the plan. IID also requests that the State Water Board modify Revised Order WRO 2002-0013 to require the State of California to fulfill its commitment to restore the Salton Sea as a condition of the Board's approval of the transfer.

ISSUES FOR DISCUSSION AT WORKSHOP

The specific relief that IID has requested pursuant to its petition may not be appropriate for several reasons. First, although the conserved water transfer from IID to SDCWA, CVWD, and MWD has the potential to exacerbate the air and water quality problems at the Salton Sea, those problems would exist in the absence of the transfer. Second, the California Water Action Plan calls for the Natural Resources Agency, in partnership with the Salton Sea Authority, to take the lead on coordinating state, local and federal restoration efforts and working with local stakeholders to develop a shared vision for the future of the Salton Sea. Third, making approval of the transfer contingent on restoration of the Salton Sea has the potential to unravel the complex series of agreements that make up the QSA, which would have significant water supply implications for the State. Despite these problems, IID has brought an issue of statewide importance to the Board's attention, and the Board is interested in hearing input from the parties on what role the Board can and should play to protect the beneficial uses of the Salton Sea, consistent with the California Water Action Plan, without jeopardizing the important water supply benefits of the QSA.

The State Water Board is aware that there are several different plans being discussed for the Salton Sea. At this workshop, the State Water Board would like to hear the status of mitigation and restoration planning, timing and funding of work, as well as efforts to provide an overall framework to address the long term Salton Sea issues. The State Water Board would like to engage in a general policy discussion of the willingness of interested parties to develop a shared vision for the future of Salton Sea, if there is not one at this time. The workshop will focus on larger planning and implementation needs rather than specific technical issues.

The State Water Board is specifically interested in receiving input regarding the following questions, based on the current status of efforts focused on the Salton Sea:

- How can the State Water Board promote implementation of a reasonable and sustainable plan to address the air, wildlife, and water quality problems at the Salton Sea?
- 2. If there is a necessary and appropriate role for the State Water Board, what specific issues or obstacles need to be addressed, and in what sequence and timeframe?
- 3. What changes, if any, should the State Water Board consider making to Revised Order WRO 2002-0013?

SUBMISSION OF WRITTEN COMMENTS

The workshop is an opportunity for interested persons to provide input to the State Water Board regarding the issues described above. The State Water Board encourages interested persons to submit their comments in writing. Comment letters should be submitted by **12 noon**, **Wednesday, March 11, 2015**.
